<b>Alert 01 (2024.09.27 00:00)</b> China, India, Indonesia, Russia, Thailand, Malaysia, and Japan	01. A free Visa regime is implemented for nationals of China, India, Indonesia, Russia, Thailand, Malaysia, and Japan with immediate effect.  02. Nationals of the above-nominated countries possessing <b>Diplomatic, Official, Public Affairs, Service, and Ordinary passports</b> are eligible to enjoy a visa-free regime under this scheme.  03. <b>Above nominated nationals</b> should apply for Electronic Travel Authorization (ETA) before arriving in Sri Lanka subject to granting/issuing free of charge.  04. Under this scheme tourists can enjoy a 30 days free visa period and a double entry facility is permitted from the date of first arrival to Sri Lanka within 30 days.  05. Applicants who have obtained a free visa and need to stay in Sri Lanka for more than 30 days can apply for an extension by paying the appropriate visa fee.  06. <b>Please note that this particular visa-free regime applies to the above seven nominated countries and the rest of the countries may follow the general rules and regulations applicable to Sri Lanka ETA.</b>

Welcome to the Electronic Travel Authorization (ETA) official website of the Department of Immigration & Emigration (DI&E) of the Democratic Socialist Republic of Sri Lanka.

For a Short Visit to Sri Lanka, (For more info...) travellers should obtain an ETA with effect from 1st of January 2012.

On the basis of reciprocity, citizens of The Republic of Singapore, The Republic of Maldives and The Republic of Seychelles are exempt from the requirement of obtaining ETA to visit Sri Lanka.

The issuing authority of the ETA is the Department of Immigration & Emigration, Colombo, Sri Lanka.

Persons intending to visit Sri Lanka can apply for ETA online. In addition to this option, an applicant may also go for one of the alternative options. (For more info...)

- (i) A round trip ticket to show at the port of entry in Sri Lanka (only if you are traveling by air).
- (ii) Evidence of sufficient funds to cover your expenses in Sri Lanka.

**2. Employment:** Holder of ETA, should not engage in any form of employment, paid or unpaid, or in any trade or business other than specified in the ETA, during the period of his/her stay in Sri Lanka

**3. Fees and Payments:** You agree that your credit card(s) will be billed immediately after submission of your application. Requirements and Fees related to processing of your application are subject to change from time to time and you agree that the ETA processing fee once paid by you is not refundable and not transferable.

**4. Communication:** By using this site, you do authorize the Department of Immigration & Emigration Sri Lanka to contact you via e-mail, messaging, or any other electronic or non-electronic means of communication.

**5. Accuracy:** By submitting your application, you do certify that the information provided by you is true and correct.

**6. Limitations of use:** You may not use this site for any purpose other than the intended purpose.

#### (1) Application Submitting Terms

- You must enter the passport number correctly
- You must enter nationality correctly as appears in the travel document
- You must enter your date of birth correctly

You must recheck / crosscheck above information to ascertain that they have been entered correctly. You are required to pay for the visa again on arrival in case of any inconsistency in above particulars.

You must make sure that the same travel document which was used for applying online visa is used for entering into Sri Lanka. In the event you produce a travel document other than the one used for applying online visa, you are required to pay again on arrival for the visa.
